"14 Support System

Support system for foreign and foreign-affiliated companies that operate globally

Each support system has eligibility requirements imposed by Hyogo Prefectural Government, Kobe City Government and the JETRO.

Office Rent Subsidy System

[Kobe City]

- Area: All areas of Kobe City
- Subsidy amount: Up to 25 % of rent (utilities and taxes excl.)
- Maximum amount: JPY \1,500/m per month; JPY \10,000,000 per year
- Max. Subsidy period: 3 years
- (5 years when a space of 1,500m and more is rented)

[Hyogo Prefecture]

- Area: Kobe International Economic Zone
- Subsidy amount: Up to 25 % of rent (utilities and taxes excl.)
- Maximum amount: JPY \750/m per month; JPY \1,000,000 per year
- (JPY 1,500/mper month; JPY 10,000,000 per year if 11+ new full-time employees are hired)
- Maximum subsidy period: 3 years

Prefectural Corporate Enterprise Tax Reduction [Hyogo Prefecture]

- Area: All areas of Kobe City
- Reduction rates *1: A 1/3 of prefectural corporate enterprise tax
- Period: 5 years
- Requirements *2: 11+new full-time local employees

(Not limited to relocation of head office functions and offices with addresses in Hyogo prefecture.)

*1,2:

A 1/2 of prefectural corporate enterprise tax reduction is applicable if a space of 1,000m or more is utilized in Kobe International Economic Zones (employment requirement is not applicable).

Q1. Why did you choose Kobe for your location?
